Dear Member of the General Assembly,

I am writing you today in emphatic support of Connecticut Energy Efficiency Fund and its direct positive impact on our company, <u>Trifecta Ecosystems</u>, <u>Inc.</u> As an aquaponic technology and indoor farming company, energy efficiency is a crucial part of making our company sustainable. This program has the potential to affect not only our business but our entire industry. It is our belief that Connecticut can be the leading state in the nation for indoor farming, should we choose to seize the opportunity. The Connecticut Energy Efficiency Fund gives Connecticut a major competitive edge on attracting innovative indoor farming companies and we urge you to maintain the fund to drive this economic growth.

In March 2017, we made an expansion to 290 Pratt Street in Meriden as the next step in our business journey. We revitalized a portion of a building that was empty for years and turned it into a highly productive indoor farm, growing food all year round in Meriden. While we were in the process of planning this new facility, we were able to get a broad range of support from Eversource in connection to using LED lighting for our new growing operation. Their expertise and guidance allowed us to receive nearly \$44,000 in rebates, which was a substantial amount for a small business like ourselves. As we opened up our facility last year, we were able to host a tour for the CT Farm Energy Program, which the utility companies were a part of. Not only were all guests impressed by our growing operation, but they also were impacted by the fact that we save approximately \$45,000 in electricity costs per year per farm by using LED lighting, which is a win-win as it reduces the load on the grid.

Restoring the CT Energy Efficiency Fund to full funding will not just help small businesses like ours expand and open new locations, but it also will create new jobs that currently do not exist. While we are a small company of only 6 people, the rebate that we received from the CT Energy Efficiency Fund allowed us to hire another full-time employee. As we look to expand to new locations over the next year, we see the rebates as a pathway for us to hire more people locally. One of the joys of being a business owner is providing jobs to people who are looking for a more rewarding career. Knowing how many people interviewed for that 1
